## Vision

## Mission

*To strengthen **global, regional & national action** in ensuring an adequate level of protection in the field of the safe transfer, handling and use of living modified organisms that may have adverse effects on the conservation and sustainable use of biological diversity, taking also into account risks to human health and specifically focusing on transboundary movements*

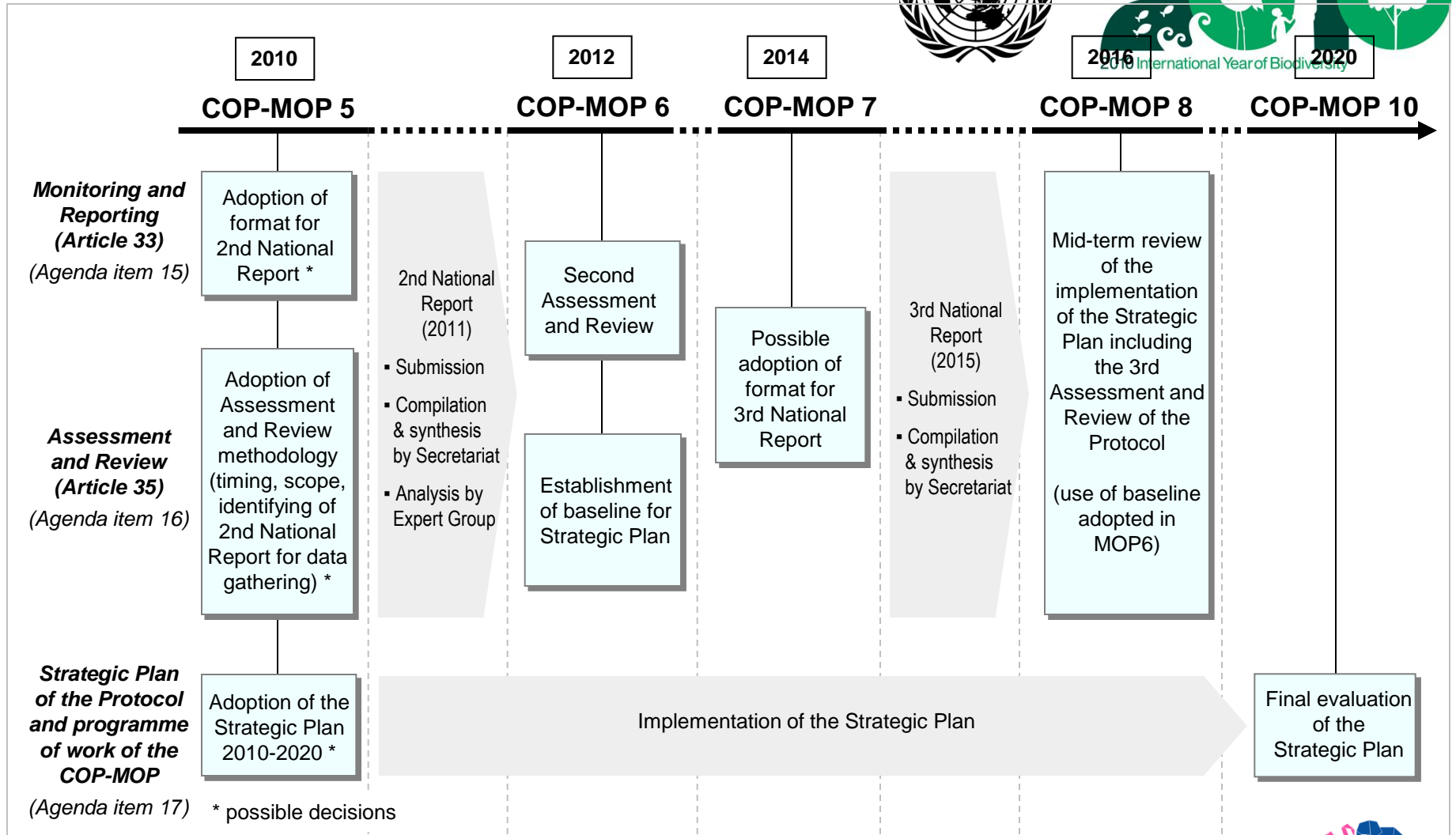
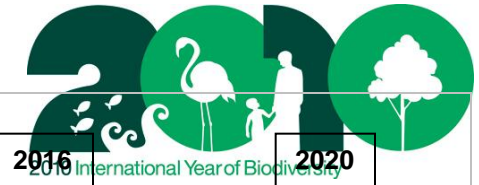


# Assumptions

- National report submitted in a timely manner
- Adequate and predictable financial resources
- Detail budgets presented biennially at COP-MOP
- For evaluation and monitoring: Assessment and Review process adopted at COPMOP-6
- Strengthening of Secretariat to fulfil its supporting role and to facilitate consistent delivery of the different components of the plan – Staff requirements
